Club Rules - General Agreement

Our members and guests are courteous, friendly, cooperative, and neat. Thank you for being one of them. The following information is provided to help create a welcome, fun, safe, and stress-free time at Lake Bronson. Please initial each paragraph, and sign below.

- _____ Participants agree to conduct themselves in accordance with the same high standards of mutual tolerance and respect which govern their actions in everyday life. Participants agree to avoid behavior which is aggressive, harassing, embarrassing, overtly sexual or otherwise inappropriate.
- _____ Participants agree to not wear clothing in general. Clothing is allowed if the weather is inclement and to prevent sunburn. On certain days, women may choose to wear shorts or similar cover up. Nudity is required in the lake, hot tub, and sauna. Respect our neighbors by keeping nudity confined to Lake Bronson Park.
- _____ Participants agree to always sit on their towel when using a chair, bench, sauna, etc. while nude. Participants agree to wear a bottom cover-up when preparing food in the public kitchen, serving food, or going through the buffet service line at community functions.
- _____ Participants agree to shower with soap and rinse well before entering the hot tub or sauna and to shower in order to remove all lotions or oils before entering the lake. Safety rules are posted in these areas. Kindly take the time to read them.
- _____ Parents are responsible for their children's conduct and safety at all times. Children age 13 or under must not swim without a parent nearby, nor use boats without a lifejacket or adult aboard.
- _____ Participants agree that videos or pictures, regardless of device, are not allowed to be taken at the beach or other shared public areas. Pictures or videos taken at club events are allowed in posted photo areas and are not allowed where someone might inadvertently appear in the picture. Pictures taken for publicity or commercial purposes require written permission of the Lake Bronson Board of Directors.
- _____ Participants agree to check at the office to see if conditions permit a campfire at the fire pit at the end of the RV Park and/or the fire pit at the beach. When you are the last one at the fire, you must extinguish the fire completely before leaving.
- _____ Pet owners agree to keep their pets under their control on a leash at their campsite or cabin and on perimeter roads. No pets are allowed on the beach, sunning lawn, in Lake Bronson facilities, or in daily rental units. Certified service animals are exempt from the above rule. Pet owners agree to immediately clean up after their pets.
- _____ Participants agree to observe all government laws at Lake Bronson Park, including those laws which prohibit the use of illegal drugs and underage drinking.
- _____ Participants agree to observe Washington State fishing regulations. Fishing gear is restricted from the lake swimming area, beach, and sunning lawn.
- _____ Drivers agree to observe the 10-mph speed limit.
- _____ Participants agree to observe that weapons and firearms are not allowed at Lake Bronson Park unless approved by the Board of Directors.
- _____ Smokers agree to smoke only at their campsite and in designated community areas. Smokers agree to not smoke on trails, in community buildings, or near doorways or windows of community buildings, and to use caution and courtesy in all areas.
- _____ Alcoholic beverages are permitted in moderation in the recreational areas and lodge. Participants agree to not leave alcohol behind in the lodge or other public areas.
- _____ Participants agree to leave their glass beverage containers at their campsite, and to not bring them to outdoor community areas.
- _____ Participants agree the hot tub and sauna areas are smoke, food, and beverage free. Drinking water is allowed.
- _____ Participants agree to not wear genital or anal jewelry at Lake Bronson.

LAKE BRONSON BEACH RULES

1. Smoke in designated areas only.
2. Nudity is required on the beach and in the water. While on the beach you should certainly cover up if you are cold or are getting sunburned. No street clothes or bathing suits. Sarongs or other nudist attire are appropriate coverups.
3. Beach chairs are on a first-come first-served basis.
4. Canoes, kayaks, and paddleboats are available on a first-come, first-served basis. Paddles and life jackets must be returned to the racks when the boat is returned.
5. No boats are allowed between the main dock and the floating dock.
6. Everyone, regardless of age, must have a Coast Guard Approved personal flotation device (life jacket) in their possession while in any watercraft.
7. Children 12 years of age and under must wear a personal flotation device (life jacket) while in or on any watercraft.
8. Parents are responsible to see that their children are conducting themselves in a safe and non-disturbing manner to other beach users.
9. No glass on the beach, which is anywhere beyond the parking lot
10. No fishing off the beach or dock.
11. Pets are not allowed on the beach or volleyball court, or left tied up in the parking lot.
12. No cameras on the beach. No photography allowed, except by express permission from the Board.
